- **John O'Keefe** and **David Bradley** are Co-Chairs of ISRA 2013, Toronto, June 9-11, 2013, the next *International Symposium on Room Acoustics*. ISRA

conferences are held at 3 year intervals as satellites to the much larger ICA conferences.

- **(Alex Case)** The Technical Committee on Architectural Acoustics maintains their TC archives at the Riverbank Building (formerly Riverbank Acoustical Laboratories) in Geneva, IL, now part of Alion Science and Technology. This archive consists approximately of the equivalent of 8 vertical file cabinets of documents as well as historical apparatus, some quite large. The archive contains many artifact documents including original papers and notebooks by Wallace Sabine, Paul Sabine, and Ted Schultz as well as the ASA 50th Anniversary materials. The ASA member and contact at Alion Science and Technology left the company that owns/leases the facility housing the archive, and questions have been raised about the safety and accessibility of those archives. After extensive discussions with Alion representatives and during the Archives and History committee meeting, the Archives and History Committee consensus was that we not take any action yet, but monitor the situation closely. In the future it may be possible that the documents from the collection at Riverbank be transferred to the AIP History Center, but this would require funding to move all the materials and get them to the AIP. The AIP History Center will not take historical apparatus currently located at Riverbank, so alternative homes would need to be found for those items.
 - Archives and History committee is keeping a close eye on this, but welcomes questions, comments and concerns. (send to your chair using alex@fermata.biz)
 - I would like to form a temporary sub-committee to ensure effective and efficient communication with Archives and History committee, and to be a strong advocate for the health, preservation, and accessibility of the archives.
